ORDINANCE O-09-12

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COLONA, ILLINOIS, AMENDING ORDINANCE 3-2-12 AND ORDINANCE 5-2-1-7 OF THE COLONA CITY CODE, SO AS TO ALLOW VIDEO GAMING IN PREMISES LICENSED TO SELL ALCOHOLIC LIQUOR, IN THE CITY OF COLONA, ILLINOIS.

WHEREAS, The Illinois Gaming Board has prepared a list of municipalities in which video gaming, as authorized by the Illinois Legislature, will not be allowed, since the municipality has a current ordinance prohibiting gambling in the municipality and the ordinance does not make an exception for video gaming, and

WHEREAS, the City of Colona is currently listed as a municipality in which video gaming is not allowed, and

WHEREAS, the City Council of the City of Colona has elected to amend current ordinance 3-2-13 in order to permit dramshops in the City of Colona to make application to the Illinois Gaming Board for a license for video gaming in their facilities.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLONA, COUNTY OF HENRY, AND STATE OF ILLINOIS:

Section 1: Section 3-2-13, entitled "Gambling," of Chapter 2 entitled "Liquor Control," of Title 3 entitled "Business and License Regulations," is hereby amended by deleting said section in its entirety and by adopting and inserting the following:

"3-2-13 C GAMBLING: There shall be no illegal card games or illegal gambling allowed on any premises licensed to sell alcoholic liquor, except for video gaming as authorized by the Illinois Legislature and as licensed by the Illinois Gaming Board, which shall be allowed.

Section 2: Section 5-2-1-7 "GAMBLING" of Chapter 2 entitled "General Offenses," of Title 5 entitled "Police Regulations," is hereby amended by the addition of the following paragraph, as the fourth and last paragraph of said section:


"The above prohibition of gambling, and possession of gambling devices or paraphernalia, shall not apply to video gaming devices, as authorized by the Illinois Legislature, and as licensed by Gaming Board, which shall be allowed."


