

**ORDINANCE OF THE CITY OF COLONA, HENRY COUNTY ILLINOIS
AMENDING TITLE 3 CHAPTER 1 SECTION 2- "APPLICATION AND
REGISTRATION" OF THE CODE OF ORDINANCES OF CITY OF
COLONA.**

Be it ordained by the Mayor and the City Council of the City of Colona, Henry County, Illinois as follows:

Section 1. That Title 3 Chapter 1 Section 2, "Application and Registration" shall be amended by adding a new subsection C. Any business within the City of Colona, Henry County, Illinois which has failed to annually register with the City of Colona by February 1st of each calendar year shall be deemed in violation of this ordinance requiring such registration. Failure to register annually with the City of Colona, by February 1st each calendar year shall carry a fine to be established under the "General Penalty Clause" of the City of Colona, Code of Ordinances.

The fine to be established for violation of the failure to register requirement may also be covered under its "No Contest" section of Chapter 5 "Fines" of the City of Colona Code of Ordinances.


Section 2. The old Subsection C of Title 3, Chapter 1, Section 2 is hereby deleted in its entirety.


Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed insofar as they so conflict.

Section 4. This ordinance shall be in full force and effect from and after its passage approval and publication as provided by law.

**ORDINANCE OF THE CITY OF COLONA, HENRY COUNTY ILLINOIS
AMENDING TITLE 5 CHAPTER 5 SECTION 2-
"NO CONTEST FINE" OF THE
CODE OF ORDINANCES OF CITY OF COLONA.**

Be it ordained by the Mayor and the City Council of the City of Colona, Henry County, Illinois as follows:

Section 1. That Title 5, Chapter 5, Section I "No Contest Fine" shall be amended by adding to its No Contest Offenses section a new offence under Title 3, Chapter 1, Section 2 (C) "Failure to Register."

Section 2. The fine or penalty for violation of requirement to register shall fall under the "General Penalty" clause of the City of Colona, Code of Ordinances.


Section 3. Violation of the requirement to register shall also fall under the Geometric Progression of Fine provided for in Title 5, Chapter 5, Section 2, with the first offence being \$50.00.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed insofar as they so conflict.

Section 5. This ordinance shall be in full force and effect from and after its passage approval and publication as provided by law.
