ORDINANCE CONCERNING JAY WALKING

WHEREAS it has become a concern of the City Council of Colona that parents and their children have been crossing Route 84 in the City at areas other than the designed cross walk; and

WHEREAS during early morning and afternoon when school is in session the existing traffic on Route 84 is very high; and

WHEREAS parents have, on occasion caused themselves and their children to Jay Walk which, at the busy times, is very dangerous; and

WHEREAS the Mayor and City Council have determined it is in the best interest of its citizens and young students to enact a Jay Walking ordinance on Route 84 and the existing school crossing;

Now, therefore, be it ordained by the Mayor and City Council of Colona, Illinois, as follows:

Section One: That Title 5, Chapter 2, Section 5 of the Code of Ordinances is hereby amended by adding thereto an additional subsection to be 5-2-5-8 entitled "Jay Walking"

Section Two: Jay Walking is defined as "Proceeding diagonally across a street intersection. Also, crossing a street between intersections, or as a place other than a crosswalk."

Section Three: Title 5, Chapter 2, Section 5-8 shall read as follows:

It shall be unlawful to Jay Walk across Route 84 in the City of Colona, Illinois within the boundaries designated as school zone by existing signs for such purposes. Enforcement of this ordinance shall be strictly applied from thirty (30) minutes before the school day commences and for thirty (30) minutes after school begins, and for thirty (30) minutes prior to the end of the school day and for thirty (30) minutes after school shall have been dismissed.

Section Four: Anyone convicted of violating this ordinance shall be subject to the General Penalty Clause of the City of Colona, Illinois Code of Ordinances.

Section Five: That all ordinances in conflict herewith are hereby repealed insofar as they so conflict.

Section Six: That the Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
