1. We had 2 people graduate from the Police Academy- Samuel Little and Joshua McKay.


PUBLIC WORKS COMMITTEE: The next Public Works Committee meeting will be Thursday, May 18, 2023 at 5:00pm.


1. Read minutes from April 20, 2023.
